

KEY DATES FOR COUNTY FCFCs

In Calendar Year 2017

OFCF OPERATIONAL CAPACITY BUILDING FUNDS GRANT APPLICATION

- Designation of Administrative Agent Form for SFY 18 is due March 17, 2017.
- SFY 18 Operational Capacity Building Funds Grant application is due July 31, 2017.

OhioMHAS GRANTS & FUNDING MANAGEMENT SYSTEM (GFMS) ALLOCATION APPLICATION

- SFY 18 Allocation Application is due by June 14, 2017.

FCFC H.B. 289 SHARED PLAN

- H.B. 289/SFY 2017-2019 Shared Plan Update is due July 31, 2017 (to be submitted along with the Operational Capacity Building Funds Grant application).

EARLY INTERVENTION

- Expenditure reports are due on a Monthly or Quarterly basis depending on what was submitted in the RFP response. You can view the reporting frequency chosen on the GMIS Application page under "Application Information." Monthly reports are due on the 10th of each month starting with the July report due on 8/10/2016 (August report is due on 9/10/2016, etc.) and ending with the June report due on 7/10/2017. Quarterly reports are due 10/10/2016, 1/10/2017, 4/10/2017 and 7/10/2017. All final expenditure reports are due on 8/5/2017.
- Program Reports – Topics to be sent to sub-grant recipients in advance of the due dates: mid-year due 1/10/17 and final due 8/5/17 submit in GMIS on the Program Report page (Can be found under the "Projects" tab on the top left side of the page).
- Inventory Report- list all equipment purchased with grant funds during FY17 (also must list equipment partially paid for with grant funds). Due August 5, 2017 (upload to the equipment section of the approved budget in GMIS)

- 1/11/17 – Deadline to submit RAR form for reimbursement fund for January processing
- 2/1/17 - FCSS Projected Expenditures form for SFY 17 due
- 2/1/17 - Semi-Annual Report for SFY 17 is due and must be submitted via online survey; Needs/Services Tracking Grid submitted to Regional Coordinator via email
- 4/12/17 – Deadline to submit RAR form for reimbursement funds for April processing (If no previous RARs have been submitted, OFCF reserves the right to reduce allocation)
- 5/10/17- Deadline to submit RAR form for reimbursement funds for May processing date
- 6/5/17- Deadline to submit RAR from for reimbursement for June processing
- 6/30/17 - Deadline to spend all SFY 17 FCSS funds
- 7/15/17- Deadline to submit final RAR form for reimbursement of FY 17 FCSS funds
- 8/15/17 - FCSS Annual Report for SFY 17 is due via online survey.

CASH BASIS REPORT

- Cash basis report to State Auditor due 60 days after the end of council's fiscal year.
