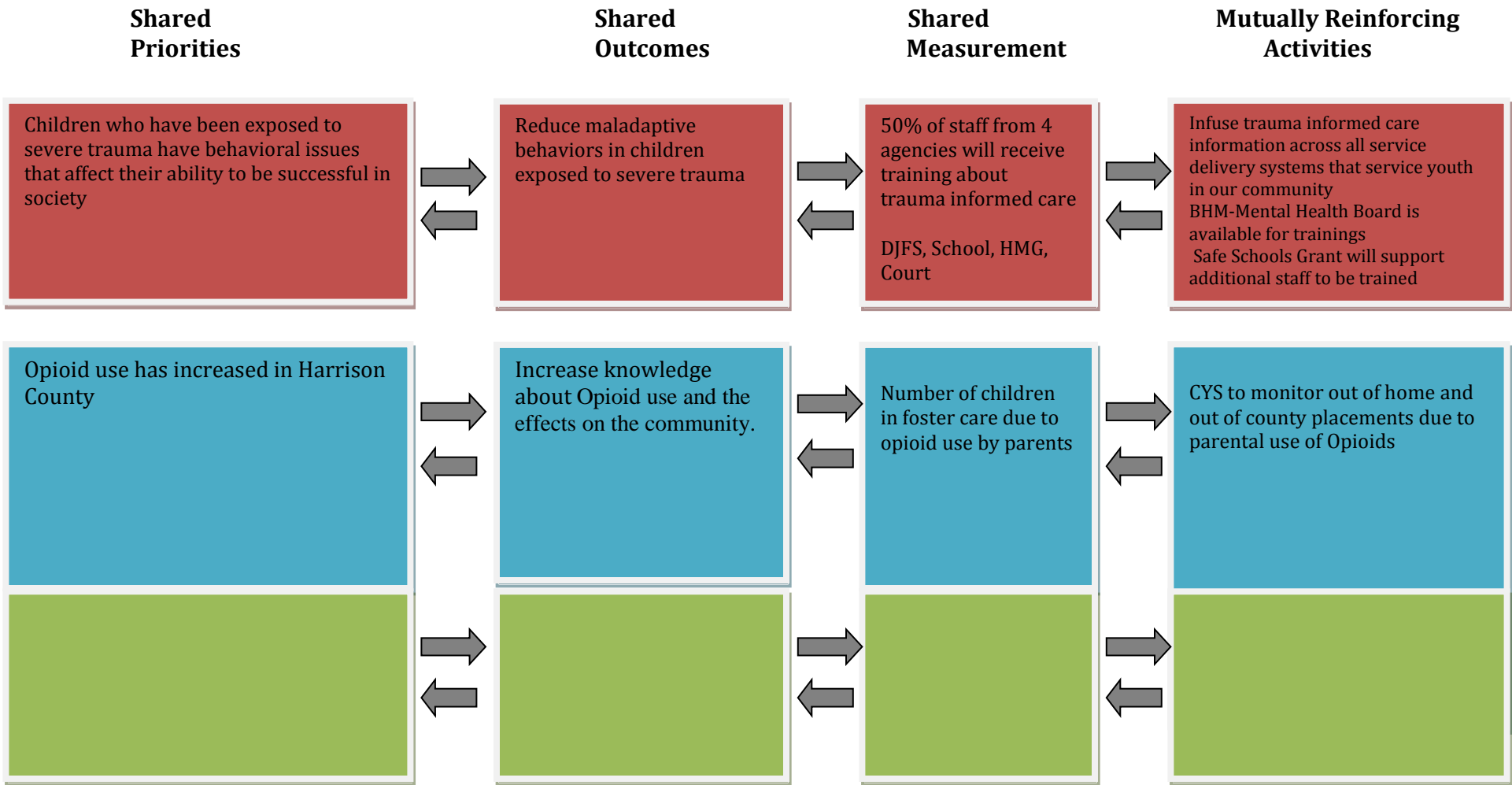


Harrison County Family and Children First Council Shared Plan Update for SFYs 17-19

In 2017 our priority was trauma informed care. ADAMAS board staff provided one training in Harrison County and 4 member agencies were able to send their staff to offsite trainings. We had planned on doing 2 training but it was difficult to find dates and times that were convenient for staff to attend from multiple agencies. So Harrison Hills City School District and Belmont County Health Department sent staff to become trainers within their departments. Harrison DD Board had started trainings last year and this year invited all council members to attend a training they sponsored. Help Me Grow Staff attended a trauma informed care workshop in Columbus and then shared the information internally

Harrison/Belmont/Monroe DD has formed a work group of multiple agencies to continue the work about trauma informed care. The first meeting was held in June and will be held quarterly
