The UW's UCAN project has shown success in its ability to move low income working families into a maintained level of self-sufficiency thus reducing their reliance on public systems. In order to support this targeted population in achieving self-sufficiency goals in the long-term, LCCFC will support professional development for the network of UCAN case managers and other direct service staff in the community. It is anticipated that this partnership will advance the knowledge of practitioners in the field working with these families and equip them with new skills to advance effective case management services.
